**ORDER**

On November 4, 2010, Xen Energy Systems, Inc., (XESI) filed a Petition for the Amendment of the Rules for Pre-paid Electric Metering System, which Rule was approved by the Energy Regulatory Commission (Commission) in ERC Resolution No. 15, Series of 2009.

During the January 5, 2011 public consultation of the instant petition, XESI presented proofs of its compliance with the Commission's posting and publication of notice requirements which were duly marked as Exhibits. Thereafter, it made an expository presentation on the proposed amendments to ERC Resolution No. 15, Series of 2009. At the said consultation, the Commission noted that only Manila Electric Company (MERALCO) had submitted its comments.
